

MEDICAL TOURIST (C-3-3)

ELIGIBILITY

Individuals intending to visit Korea for medical treatment or recuperation at a medical institution and the patient's immediate family member (spouse, parents, grandparents, children or grandchildren) who will act as a caregiver.

- ※ Non-family caregivers are only allowed when the patient is funded by the government.
- ※ A caregiver who does not travel together with a patient is not eligible to apply for a medical tourist (C-3-3) visa.

The Mongolian nationals, where eligible and suits the purpose of travel, can apply for medical tourist (C-3-3) visas at KVAC or at the authorized agencies. The persons can apply for a single-entry visa (maximum duration of stay 90 days). The Korean Diplomatic mission can ask for additional documents.

Authorized hospital issuing medical certificates

National Trauma and Orthopedic Research Center, National Cancer Center of Mongolia, The First, Second, and Third State Central Hospitals, Intermed Hospital, Grandmed Hospital, and UB Songdo Hospital.

1. A patient who already visited Korea more than twice with a Medical Tourism Visa (C-3-3)

2. A patient who has paid already at least KRW 10,000,000 of the medical treatment

Original invitation letter from a Korean hospital; Original confirmation of the appointment with the doctor in the Korean hospital; Copy of the business registration certificate of the Korean hospital; and Copy of the proof of registration of the Korean hospital as a certified institute for foreign patient treatments.
2. Visa Application Form, one 3.5x4.5 cm picture taken in the past 6 months
3. Passport in original and a copy
4. Invoice of the pre-paid payment (remittance, bank statement, card slip) stating the name of the remitter and the payee (remittance can be made by patients or their immediate family members)
5. A medical certificate issued by one of the authorized hospitals in Mongolia
6. Marriage certificate (issued within the last 45 days from the application date)
7. Proof of financial capability <ul style="list-style-type: none">• Business owner: Tax payment certificate, business registration certificate• Employee: Confirmation of social insurance payment, certificate of employment• Other cases: Bank statement under the name of the applicant for the past 6 months (joint accounts are not accepted)

3. A patient who is going to have surgery in Korea

Original invitation letter from a Korean hospital; Original confirmation of the appointment with the doctor in the Korean hospital; Copy of the business registration certificate of the Korean hospital; and Copy of the proof of registration of the Korean hospital as a certified institute for foreign patient treatments.
2. Visa Application Form, one 3.5x4.5 cm picture taken in the past 6 months
3. Passport in original and a copy
4. A medical certificate issued by one of the authorized hospitals in Mongolia; and A confirmation of the appointment for the surgery from the Korean institution
5. Marriage certificate (issued within the last 45 days from the application date)
6. Proof of financial capability <ul style="list-style-type: none">• Business owner: Tax payment certificate, business registration certificate• Employee: Confirmation of social insurance payment, certificate of employment• Other cases: Bank statement under the name of the applicant for the past 6 months (joint accounts are not accepted)

4. A critical patient with acute disease and caregiver including the immediate family member of the patient

Copy of the business registration certificate of the Korean hospital; and
Copy of the proof of registration of the Korean hospital as certified institute for foreign patient treatments.

 3. Passport in original and a copy
 4. Marriage certificate (issued within the last 45 days from the application date)
 5. A medical certificate issued by one of the authorized hospitals in Mongolia
 6. Proof of financial capability
 - **Business owner:** Tax payment certificate, business registration certificate
 - **Employee:** Confirmation of social insurance payment, certificate of employment
 - **Other cases:** Bank statement under the name of the applicant for the past 6 months (joint accounts are not accepted)

An immediate family member and/or a caregiver

✘ If the caregiver is not traveling together with the patient, the person is not eligible to apply for a medical tourist (C-3-3) visa.

5. An old-aged pensioner patient

4. Retirement book copy
5. A medical certificate issued by one of the authorized hospitals in Mongolia
6. Marriage certificate (issued within the last 45 days from the application date)

6. A patient who had a surgery in the past 2 years in Korea:

Original invitation letter from a Korean hospital; Original confirmation of the appointment with the doctor in the Korean hospital; Copy of the business registration certificate of the Korean hospital; and Copy of the proof of registration of the Korean hospital as a certified institute for foreign patient treatments.
2. Visa Application Form, one 3.5x4.5 cm picture taken in the past 6 months
3. Passport in original and a copy
4. Previous records of medical treatment in Korea; The specification in the confirmation of appointment for treatment of returning patient or routine examination
5. Marriage certificate (issued within the last 45 days from the application date)
6. Proof of financial means <ul style="list-style-type: none">• Business owner: Tax payment certificate, business registration certificate• Employee: Confirmation of social insurance payment, certificate of employment• Other cases: Bank statement under the name of the applicant for the past 6 months (joint accounts are not accepted)
※ The above documents must prove that the applicant can afford the cost of treatment and stay in the country.

7. A patient who will undergo surgery in Korea sponsored by a charity organization in Korea and the immediate family member as a caregiver:

Copy of the business registration certificate of the Korean hospital; and
Copy of the proof of registration of the Korean hospital as a certified institute for foreign patient treatments.

3. Passport in original and a copy
4. An official invitation letter issued by the charity organization
5. A medical certificate issued by one of the authorized hospitals in Mongolia
6. Marriage certificate, family relation certificate (issued within the last 45 days from the application date)
7. Proof of financial capability
 - **Business owner:** Tax payment certificate, business registration certificate
 - **Employee:** Confirmation of social insurance payment, certificate of employment
 - **Other cases:** Bank statement under the name of the applicant for the past 6 months (joint accounts are not accepted)

※ The above documents must prove that the applicant can afford the cost for treatment and stay in the country.

An immediate family member who is accompanying the patient as a caregiver

※ If the caregiver is not traveling together with the patient, the person is not eligible to apply for a medical tourist (C-3-3) visa.
